FEES:

\$2,250 for 5 hours of continuous wedding photography - \$125/hr beyond 5 hours. Minimum charge is \$2,250 plus tax and travel expenses. A nonrefundable retainer of \$500 is due at the time of entering into this agreement. Client shall be responsible for the applicable sales tax. Full payment is due 30 days before the wedding. Client will pay Photographer's travel expenses from Denison, Iowa. Mileage is calculated at \$0.48 cents a mile. Miles are determined by google maps. Client shall provide hotel accommodations for Photographer and one assistant if total round trip mileage exceeds 400 miles. Client will provide meals for Photographer and one assistant during the reception UNLESS Photographer is given prior notice otherwise. Photographer photographs better when he's not hungry.

ENTIRE AGREEMENT:

This agreement contains the entire understanding between Photographer and the Client. It supersedes all prior and simultaneous agreements between the parties, whether written or oral. The only way to add or change this agreement is to do so in writing, signed by all the parties. If the parties want to waive one provision of this agreement, that does not mean that any other provision is also waived. The party against whom a waiver is sought to be effective must have signed a waiver in writing. This agreement shall be governed by the laws of Iowa. The parties agree to subject themselves to the jurisdiction and venue of Crawford County, Iowa.

COOPERATION:

The quality of photos is directly related to the cooperation, excitement, and attitudes of everyone involved. The parties mutually agree to cheerfully cooperate and communication for the best possible result within the definition of this assignment. The Photographer cannot be held accountable for not photographing desired people if there is no one to assist in identifying important people or gathering people for photographs. Photographer requests to be the exclusive photographer during the formal settings. Family and friends are welcome and encouraged to photograph candid photos at any time, but not to interfere during the formal settings.

HOUSE RULES:

The Photographer is limited by the guidelines of the ceremony official or reception site management. Client agrees to accept the technical results of their imposition on the photographer. It is not Photographers practice to use flash during indoor ceremonies.

LIMIT OF LIABILITY:

In the unlikely event that Photographer is injured or becomes too ill to photograph the event, Photographer will attempt to secure a replacement photographer. If the situation should occur that a suitable replacement is not found, responsibility and liability is limited to the return of all payments received. Photographer takes the utmost care with respect to exposure and composition but shall not be held liable for equipment failure. The parties agree that in all other circumstances of loss, liability is limited to the return of all payments received by Photographer to Clients. The limit of liability for a partial loss of originals shall be a prorated amount of the exposures lost based on the percentage of total number of originals. The parties agree that Photographer's liability shall at no time exceed the amount paid by Client to Photographer. If Client fails to perform, liquidated damages shall be the reasonable amount paid by Client as a nonrefundable retainer.

COPYRIGHT AND MODEL RELEASE

Photographer irrevocably grants to Client, and Client's assigns, the non-exclusive right to use images created by Photographer for Client on Client's Wedding Date in all forms and medias, for all purposes. Client hereby grants to Photographer, or his assigns, permission to use and publish photos in which Client appears without incurring any debts or liabilities of any kind.

We, the undersigned parties, have read and understood the terms above and hereby mutually agree to the terms of this agreement.
